

**TERMS AND CONDITIONS FOR  
ASHFIELD MALL'S WIN 1 OF 3 FAMILY DAY PASSES TO RAGING WATERS SYDNEY  
ONLINE COMPETITION**

1. Participation in this Promotion and information regarding redemption of any prize forms part of these terms and conditions. Participation In WIN 1 OF 3 FAMILY DAY PASSES TO RAGING WATERS SYDNEY ("Promotion") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local daylight savings time.

2. Subject to condition 3, this Promotion is only open to NSW residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions.
